		Two good quality recent color passport photographs on white background					
		One photocopy of the data page of applicant's passport.					
		Original and a photocopy of the Family Registration Certificate legalized by the Ministry of Foreign Affairs of Pakistan and subsequently by the Embassy of Spain to Pakistan. ALL THE MEMBERS OF THE FAMILY HAVE TO BE INCLUDED IN THE CERTIFICATE. Then an authorized translator must translate it into Spanish.					
		One copy of the Spanish "Documento Nacional de Identidad" or Identity Card/Passport of the EU-citizen living in Spain endorsed by a "Notario Público" in Spain.					
		Original and a photocopy of the "INSCRIPCIÓN EN EL REGISTRO CIVIL ESPAÑOL POR ADQUISICIÓN DE LA NACIONALIDAD ESPAÑOLA" of the son/daughter living in Spain.					
		 Only if the Pakistani person living in Spain has got married a Spanish or an EU citizen: One copy of the Spanish Resident Card (NIE). Original and a photocopy of his/her Pakistani Birth Certificate. This Birth Certificate has to be legalized by the Ministry of Foreign Affairs of Pakistan and subsequently by the Embassy of Spain to Pakistan. Then an authorized translator must translate it into Spanish in Spain. 					
		Original and a photocopy of the "Acta de Manifestaciones" endorsed by a "Notario Público" in Spain, stating the consent of the Spanish son/daughter or the EU-citizen relative for the applicant to travel or be reunited with him/her in Spain.					
		Proof of Financial Support justifying the dependency from the relative in Spain. It is advisable to provide certificates issued by money transfer enterprises (Western Union, Ria, Small World, etc.) instead of unreadable receipts.
